- \* Circulars and Orders issued from time to time by Department/Government shall be strictly fulfilled.
- \* The Balance Sheet shall be submitted after examination by Auditor : Department Head, fixed by the Department.
- \* Kannada language shall be taught compulsorily as per Language Principles of the Government.
- \* Information Board of fee structure imposed on students shall be exhibited in school.
- \* Furniture to School Office and class room of students shall be furnished.


apart from which steps will be taken to register criminal case in local police station against the school under section 127.
